Friday, July 18, 2014 (33 days prior to the date of the Primary Election)

The last day a candidate may give or loan their campaign more than \$5000.

Friday, October 3, 2014, (45 days after the date of the Primary Election)

The last day a candidate may accept contributions.

Sunday, February 1, 2015*

The date by which candidates must distribute the amount held in their campaign account.

Other Relevant Dates for the 2014 State General Election:

Friday, October 3, 2014 (33 days prior to the date of the General Election)

The last day a candidate may give or loan their campaign more than \$5000.

Friday, December 19, 2014 (45 days after the date of the General Election)

The last day a candidate may accept contributions.

Sunday February 1, 2015*

The date by which candidates must distribute the amount held in their campaign account.

* Due date is on a weekend – will be considered timely, if completed the next business day

**During the 9 days before an election, you must report the contributor name and amount of all monetary and non-monetary contributions over \$250 to APOC within 24 hours of the time you receive each contribution.

You may need to report each day during that period, or not at all.
